Vice President, Mike Taylor called the meeting to order at 6:10 pm at the Davidson Middle School, Crestview.

## General Business:

- 1. August will be the general meeting voting new people to board and then the board voting on officers.
  - a. No two people from the same household can be on the board as voting members. One may be a voting member and the other can be a committee chair but not be able to vote.
  - b. There will be 3-3year terms to vote onto the board with the current 3 year becoming 2-year members, and 2-year terms becoming 1-year members.

## New Business:

- 1. Landscaping Committee: David Patriquin
  - a. No electrician to put lights in at back entrance. Every time David gets one they pull out. David not giving up though. (Thank you David for all of the hard work you have done. You have accomplished so much for our community that a Thank you is not enough).
- 2. ARC Committee: John Joyce
  - a. Pool on Appaloosa in and fenced.
  - b. Hot tub and rear deck on Paddock.
  - c. Privacy fence being put around auxiliary generator for home lighting.
  - d. The reason you need to submit plans is so that nothing gets put in on your septic leach field.
- 3. Treasurer Update: Laverne Wichman
  - a. As of 06/20/06, the balance in escrow is \$4,003.50
  - b. As of 06/20/06, the balance in checking account is \$40,623.79.
  - c. Please do not forget that there is still a lot of work to be done to make your community prettier and safer for all of us.
- 4. Pool Committee: George Monterio
  - a. Bathroom need soap dispensers, paper towel holders and towels, and toilet paper. George told he has \$150 a month to supply those things if he needs it.

- e. Pool bill was higher this time due to more chemicals having to be added to keep the pools Ph balance where it needs to be.
- f. If pool has to be shocked pool will have to be closed anywhere from 24 to 72 hours.
- g. People leaving things at the pool. If you have something missing contact George Monterio. He plans on hopefully adding a lost and found box that thing can be put in but not taken out without a key that he or someone he designates will have.
- h. Cracks will be resurfaced after the swimming season.
- i. George is working on getting more lights added to pool for night swimming.

  - a. Three new people added to community. Two on Arabian Court and One on Shire Lane.
  - b. Eight houses in area are up for sell.
- 6. Yard of the Month: Leigh Williamson
