Pulling weeds; inside and outside of the community pool area.

Trim trees and bushes in and around pool area.

Pool complex Security issues;

Check cameras for proper function, periodically year around; If it should become necessary, capture and record on disc the improper activities for possible prosecution.

Replace Light bulbs; 1) Street; 2) Pool Area; and 3) Parking Lot;

Reduce pool area lamp usage during winter close down months;

Reduce pool pump usage from 24/7 to 4hrs/night during close down.
