<u>Chickens in the Subdivision:</u> Chickens previously identified and discussed with the owner are still there. Chuck will call the county about the issue.

Equipment in Driveway: There is a house at xxxx that has a chrome trailer that is not in compliance with the covenants. Chuck will visit the residents and explain what must be done with the trailer.

<u>Unrepaired Yard:</u> A house at 6393 Havenmist Lane which had to replace the septic drain field a year ago has not done anything to repair the lawn damage that occurred. Chuck will visit the residents and discuss what needs to be done.
