<u>Power at the Lake Silver Entrance:</u> Dennis is still trying to get the contractor to finish the project.

<u>Street Sign Cleaning:</u> Chuck has made contact with Spanky's Power Washing Service to clean the street signs. Cost is \$300. Dennis made the motion to allow expenditure of funds for the project, Chris seconded. Motion passed.

#### **New Business:**

<u>Chickens in the Subdivision:</u> Chickens previously identified and discussed with the owner are still there. Chuck will revisit the residents. It was noted by an attendee that the resident has moved.

**Equipment in Driveway:** Also, the house next to the house with the chickens has a chrome trailer that is not in compliance with the covenants. Chuck will visit the resident.

<u>Unrepaired Yard:</u> A house on Havenmist Lane which had to replace the septic drain field a year ago has not done anything to repair the lawn damage that occurred. A letter to the owners has been prepared for the President's signature, requesting the yard be repaired.

<u>Volunteers:</u> A disabled resident of Silver Oaks has asked that volunteers be available to cut grass and other yard work for people you cannot do it themselves and can't afford to pay a lawn service. This subject is open for discussion. Chuck indicated this should remain on Facebook and managed from there with no association involvement.

<u>Lake Silver Entrance</u>: A Phase II resident has complained about the appearance of the Lake Silver Road entrance. She has been invited to address her concerns and offer some ideas to make the area more beautiful. The resident wasn't at the meeting, but it was noted that K&R cuts had not mowed the grass in the area. Chuck was going to talk to K&R Cuts about their contract obligations.
