- Pool Chair
  - 1. Pool passes are being programmed Dates are being finalized for pass distribution prior to opening and additional during season.
  - 2. Pool opens March 14, 2020 at start of Spring Break
  - 3. Spanky's Power Wash will be cleaning up the pool area February 25
  - 4. Gates to open 6 am close 10 pm starting March 14, 2020
  - 5. Pool address is 5898 one of the numbers fell so it looks like 5868. Mac will repair.
  - 6. Toilet repair was done bill to be paid
  - 7. Shed in the back was cleaned out and stabilized. We need a new door as the wood sash is rotted and cannot be repaired. Eileen will look into this.
  - 8. Phoenix Pools will do inspection on Feb 26 @ 11 am.
  - 9. Awaiting approval on pool pass agreement from legal per Chuck
  - 10. Letter was sent to Phase I re: cost for pool passes now \$175/family
